The Washington Baltimore Center for Psychoanalysis (WBCP) is now accepting applications for the 2025-2026 Combined Child and Adolescent Psychoanalytic Fellowship Program and Candidate Seminar. This program is offered jointly with the Contemporary Freudian Society.

The Combined Child and Adolescent Psychoanalytic Fellowship Program and Candidate Seminar is a tuition-free program for trainees and graduates in Psychiatry, Psychology, Clinical Social Work and Professional Counseling, and advanced practice registered nurses who have an interest in clinical work with children and adolescents. The Fellowship Program focuses on the study of psychodynamic/psychoanalytic/developmental theory and technique as a body of knowledge and framework, with which to understand and carry out the rapeutic work. In addition to participating in the Program, Fellows can also attend Scientific Meetings and other conferences sponsored by the WBCP at no charge. While there is no tuition fee for any program, including the Child Fellowship Program and Candidate Seminar, if a Fellow would like to receive CME/CE there will be a fee per credit hour, as outlined below.

The Candidate Seminar provides an opportunity for all participants to listen to child psychoanalytic case presentations by child candidates in training from the Washington Baltimore Center for Psychoanalysis and the Contemporary Freudian Society. Senior child analysts from both training programs will join as both presenters and discussants. In addition, each year child and adolescent psychoanalysts from other APsaA Institutes are invited to present their work both inside and outside the consulting room.

Many participants in the Fellowship Program and Candidate Seminar work in community mental health settings. Seeing children and adolescents in our consulting rooms is only one of many applications of psychodynamic and psychoanalytic theory and technique and we view community psychoanalysis as equally one of its applications. Case presentations will consist of a balance between children and adolescents who are seen in private practice settings and those who are seen in community mental health settings, providing opportunities to discuss a wide range of cases and to consider social, cultural and racial diversity.







The Combined Child and Adolescent Fellowship Program and Candidate Seminar will be held approximately twice a month on Monday evenings from 7:30-9:00 PM, during the 2025-2026 academic year for a total of 16 sessions.

NOTE: All classes will be conducted via Zoom.

Application Process for Child and Adolescent Fellows:

Please fill out and submit an application form online https://wbcp.memberclicks.net/25-26fellowships-application and the following documents are required and can be uploaded with the form. There is a \$40 application fee.

- A short personal essay (two pages maximum) describing the development of your interest in the application of psychoanalytic and/or psychodynamic concepts;
- Two letters of recommendation from professionals who have direct knowledge of vour therapeutic work with individuals; Please address letters of recommendation to: Mr. Joseph Chirico, Executive Director, WBCP
- Your current curriculum vitae, including name, physical address, email address, date of birth, birthplace, phone number.
- If you have previously participated in a WBCP Fellowship, you only need to submit an updated CV. An essay and letters of recommendations are not needed again.

Applications must be received by June 30, 2025. Fellowships will be announced in early September 2026.
