2019-2020 Joint Continuing Case Seminar dates  
Saturdays, 10:00 – 11:30 am (15 sessions)

September 21; October 12; November 2 & 16; December 7 & 21; January 11 & 25; February 8 & 22; March 7 & 21; April 4 & 18; and May 2. (Snow Date May 16, 2020)

Objectives of the Joint Continuing Case Seminar. Through discussion of clinical material, participants will be able to:

1. Discuss the flow, the deepening of the transference and the intensification of meaning in successful analytic work.
2. Observe the immediate and long-term effects (both positive and negative) of various psychoanalytic interventions.
3. Describe the contribution of the non-verbal as well as the verbal interactive process in the movement of a psychoanalytic experience.
4. Identify and appreciate theoretical variations in understanding and dealing with moment-to-moment psychoanalytic interactions.
5. Critique differing analytic approaches.
6. Identify issues of analyzability as demonstrated in clinical material.
7. Integrate understanding of developmental history as it emerges in transference relationship.
8. Predict from clinical hour patient's potential response to interpretation of defense or other interventions.
9. Understand how analyst may use awareness of counter transference issues as they are or become manifest in development of analytic field.
10. Demonstrate their capacity to listen analytically.
11. Demonstrate an increased capacity to integrate knowledge of developmental history with understanding of current clinical presentation.
12. Demonstrate through participant's questions and understandings increase in their ability to recommend potential usefulness of other moment-by-moment clinical interventions.
13. Demonstrate an increased capacity to utilize knowledge of developmental history and current clinical situation in formulating interventions.
14. Increase their capacity to distinguish real and transference aspects of relationship between patient and analyst.
15. Increase their capacity to think analytically.
16. Clarify, where possible, what is mutative in technique.
17. Develop the ability to identify the existence of enactment in the analytic process with clinical material.
