# **Presentation 1:**

"The Role of Secrets in an Adolescent's Racial and Sexual Identity" with Justine Kalas Reeves, LICSW, PsyD

In concurrent work with an adolescent and the parents, the role of family secrets and intergenerational trauma was crucial to understanding the challenges to an adolescent in crafting a racial and sexual identity.

Justine Kalas Reeves, LICSW, PsyD, is a child, adolescent and adult psychoanalyst in Washington, DC. She teaches at Contemporary Freudian Society, Washington Baltimore Center for Psychoanalysis, and is an Affiliate Assistant Professor at Howard University's College of Medicine. She trained in child/adolescent psychoanalysis at the Anna Freud Centre, and in adult psychoanalysis at DC's Contemporary Freudian Society. She has published book chapters and articles on child and adolescent analysis.

# **Objectives:** Participants will be able to

- Differentiate family secrets about racial and sexual identity from an adolescent's search for the self.
- Identify how concurrent work with parents of at-risk adolescents facilitates the aims of treatment.

# **Presentation 2:**

"A Perspective on Defense Analysis, With a Review of the Work of Paul Gray" with Barry Landau, MD

This presentation will first trace the history of the evolution of psychoanalytic technique from its roots in hypnosis, which bypasses the patient's defenses, to a point where analysis of defense became possible. Next, a discussion of Paul Gray's work, beginning with the clinical observation that resistance is an inevitable and evidence-based, observable development in all psychoanalytic and psychodynamic treatments and how Gray's method of "close process attention" evolved from that

observation. Finally, a discussion of Gray's concept of superego analysis as distinguished from therapeutic use of superego transference. And it will conclude with a discussion of how the concepts described above can be applied in a broader context of clinical situations.

Dr. Landau is board certified in adult, child and adolescent psychiatry and psychoanalysis. He is a Training Analyst Emeritus and Supervisor at the Washington Baltimore Center for Psychoanalysis, an instructor in adult, child and adolescent psychoanalysis, as well as a Clinical Professor of Psychiatry and Behavioral Sciences at the George Washington University Medical Center. Dr. Landau is also an instructor of child health and development (child psychiatry) At Children's Hospital National Medical Center.

# **Objectives:** Participants will be able to

- Discuss the evolution of psychoanalytic technique from its roots in hypnosis, where defenses were bypassed, to a point where analysis of defense became possible.
- Explain the idea that resistance is an evidence-based observable clinical phenomenon and how Paul Gray based his "close process attention" method on that observation.
