Presentation: Dr. Hill will discuss the challenges of working with patients with psychosomatic disease. He will present medical cases from both a medical and a psychoanalytic perspective and discuss the theories of mind-body interaction and therapeutic modalities.

Presenter: Dr. Bruce Hill is a clinical candidate at the Baltimore Washington Center for Psychotherapy and Psychoanalysis and has a private practice in Psychiatry and Psychoanalysis in Dupont Circle, Washington DC. He works at the Washington DC, VA Medical Center in the Substance Abuse Recovery Program as an addictions specialist. He is a Clinical Assistant Professor at Georgetown University and is involved with psychiatry resident education. Dr. Hill trained to become an internist and board-certified rheumatologist in South Carolina and practiced rheumatology and pain management for 11 years in North Carolina before retraining in psychiatry at Emory University in Atlanta, Georgia.

The case conference is extended to psychoanalysts, psychiatrists, psychologists, social workers, licensed counselors, mental health students, clergy, and other mental health providers interested in psychoanalytic theory, practice and perspectives.

Purpose of the Case Conference:
